PMKVY

It is Pradhan Mantri Kaushal Vikas Yojana. The aim of the scheme is to encourage aptitude towards employable skills and to increase working efficiency of probable and existing daily wage earners, by giving monetary awards and rewards and by providing quality training to them. It is totally a free Scheme. Average award amount per person has been kept as Rs. 8,000/-

PARENT MINISTRY

PMKVY is implemented by National Skills Development Corporation (NSDC) under the guidance of the Ministry of Skill Development and Entrepreneurship (MSDE). With a vision of a "Skilled India", MSDE aims to skill India on a large scale with speed and high standard.

SOURCE OF RULES AND REGULATIONS

- Posters relating to this Scheme including flyer/ text messages/ emails must be clearly displayed at the Training Centres area and classrooms, counselling room etc.
- Upload/Provide all the Aadhaar and bank related details of the candidates before the end of the training

WHO CAN BE PART OF

- Candidates from almost all the states can get benefit from this scheme. Any unemployed youth or school/college dropouts can enrol in this scheme.
- Applicant must possess an Aadhaar card and a bank account to apply in PMKVY.

MAIN AIM OF THE PROGRAM

The objective of this Skill Certification Scheme is to enable a large number of Indian youth to take up industry-relevant skill training that will help them in securing a better livelihood.
